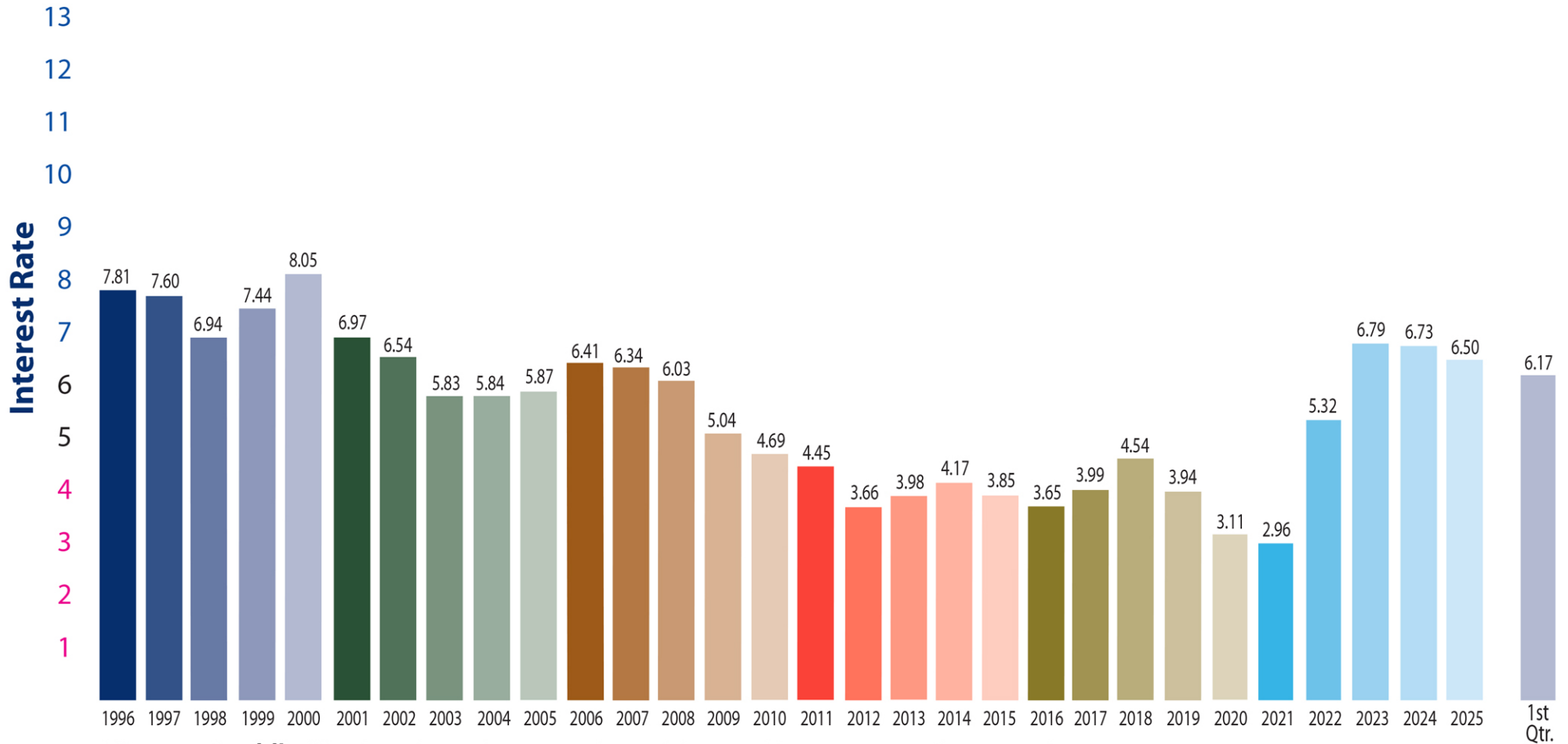


Historical Rates (Freddie Mac*) on 30-Year Fixed-Rate Mortgages
